All personnel are empowered to stop work if they believe that their personal health, safety and welfare are at risk or that their actions may result in an illegal act of environmental pollution.

Sauter will ensure that all personnel receive health, safety, welfare and environment related information, instruction, training and supervision. Sauter will secure commitment from all individuals by promoting cooperation and consultation on health, safety, welfare and environment matters throughout Sauter.

Continuous monitoring and auditing will take place to ensure that health, safety, welfare and environmental standards are met and maintained and feedback will be sought from all Management to ensure continuous improvement.
